## GDPR DATA PROTECTION NOTICE

I represent that I have been informed that:

1. Międzynarodowe Targi Gdańskie SA [MTG SA Gdańsk International Fair Co.] with its registered office at ul. Żaglowa 11, 80-560 Gdańsk, Poland, KRS No. 0000038362, is the Controller of my personal data (hereunder: "Data Controller"),
2. my personal data will be processed for information, advertising and promotion purposes and for the purposes of organising and holding the TRAKO International Railway Fair organised by the Data Controller in 2021 and in subsequent years, and for the purpose of compliance with the legal obligations of the Data Controller (in particular as regards tax settlements and accounting documentation),
3. my personal data will be processed on the basis of: GDPR Article 6.1.a) (i.e. freely given consent), GDPR Article 6.1.c) (i.e. compliance with the legal obligations to which the Data Controller is subject as regards tax settlements and accounting documentation) and GDPR Article 6.1.f)—legitimate interests of the Data Controller (i.e. direct marketing purposes of the Data Controller, especially related to the advertising, promoting, organising and holding of the TRAKO International Railway Fair, organised by the Data Controller in 2021 and in subsequent years),
4. recipients of my personal data may include the organisers and participants of the TRAKO International Railway Fair organised by the Data Controller in 2019 and in subsequent years, as well as entities which maintain the IT infrastructure, entities which provide consulting, legal and security services to the Data Controller,
5. my personal data will not be transferred to any third countries or international organisations; however, due to the public disclosure of personal data, it cannot be ruled out that entities with their registered office or domicile outside of the European Union or the European Economic Area, as to which the European Commission has not decided on an appropriate level of personal data protection, may find out about my personal data,
6. my personal data will be stored by the Data Controller over a period necessary to pursue the purposes of processing as specified in Clauses 2 and 3 above or until this consent is withdrawn by me,
7. I have the right to request from the Data Controller access to and rectification or erasure of my personal data, or restriction of processing of my personal data, or to object to such processing, as well as the right to data portability; these rights may be limited only pursuant to universally applicable laws and only in the scope specified therein,
8. I have the right to lodge a complaint with the President of the Polish Personal Data Processing Authority (UODO), which is an independent supervisory authority referred to in GDPR Article 4.21,
9. I have the right to withdraw this consent at any time, without affecting the lawfulness of processing based on the consent before its withdrawal,
10. this data processing consent has been given by me freely and does not result from a statutory or contractual requirement; however, the providing of this consent is a condition to properly meet the purposes specified in Clauses 2 and 3 above,
